Information displayed is based on selections made in Document Locator and Document Outline

DOCUMENT TAB
Contains specific detail selected. Link at top-right of this area allows user to open information in PDF or WORD document.

PROPERTIES TAB
This tab provides information about the item such as Title, Description, Versions, Effective Dates, etc.

RELATED ITEMS TAB
This tab provides links to available information related to this item (e.g. Related Filings, Dockets, Tariffs, etc.)

(STEP 1) In DOCUMENT LOCATOR, click “+” to expand items and select desired type

(STEP 2) In DOCUMENT OUTLINE, Click “+” to expand items and select desired document

(STEP 3A) Select the DOCUMENT tab to see specific available information

(STEP 3B) Select the PROPERTIES tab to see information about the document
(Document Versions, Effective Dates, Titles, Descriptions, etc.)

(STEP 3C) Select the RELATED ITEMS tab to access related documents

(STEP 3D) Click “Show PDF” or “Show Word” to open items as a PDF or WORD document

 - Properties tab contains Tariff, Section Title, Description, Effective Date, Narrative and Version
 - Related Items tab contains a link to associated filings.

- **TARIFF > OPEN ACCESS TRANSMISSION TARIFF**
 - This section contains SPP's current OATT with all revisions accepted by FERC.
 - The Document Outline section contains links for Sections, Schedules and Attachments
 - Properties tab contains Tariff, Section Title, Description, Effective Date, Narrative and Version
 - Related Items tab contains a link to any associated filings

- **TARIFF > SERVICE AGREEMENTS**
 - This section contains Service Agreements that have been issued since July 26, 2010
 - Listing organized by Service Agreement Number and Transmission Provider
 - Properties tab contains Tariff, Section Title, Description, Effective Date, Narrative and Version
 - Related Items tab contains a link to any associated filings

- **DOCKET**
 - This section contains copies of the FERC Notification of Acceptance of the Filing
 - Properties tab contains Docket Number,
 - Related Items tab contains a link to the associated filing.

- **FILING**
 - Items are listed by title of the filings
 - Click the filing in the DOCUMENT tab to see a list of all filing documents
 - Properties tab contains Filing Title, Filing Date, Tariff Title, docket number and Docket(s)
 - Related Items tab contains a link to Dockets, Associated Filings and Tariffs.
